

Core Principles

CR LIMITATIONS

- Conflicting and overlapping policies and programmes
- Unnecessary constraints and hurdles in the statutory system
- Lack of trust
- Different standards and priorities
- Cultural resistance to partnerships and joint ventures

- Simplify statutory requirements
- Make it easier to do business

- Trinidad and Tobago Micro and Small Enterprise Council (TTMSEC)
 - Ensures greater collaboration and coordination of policies and programmes that impact the MSE sector
 - Provides feedback and recommendations for MSE Development Policies in particular and national policies in general
 - Includes participants from public and private sectors, Academia, Civil Society and MSME Representatives
- Advocacy to respond to and anticipate MSME issues

- National Integrated Business Incubator System
- FairShare Programme
- MSME Portal
- MSME Diaspora Linkages

CR Enterprise Investment Fund

- Funding for programmes that support MSE development
- Participation by private sector experts into MSE development
- Preference given to certified professionals with the objective of ensuring that MSEs are afforded the highest quality services
- Project must have a self-sustainability plan and must directly benefit MSEs
- Standard setting and capacity development
- Rewards innovation by service providers and/or beneficiaries

National Integrated Business Incubator System (IBIS)

- Provides funding, business space and mentoring
- Encourages networking, forward and backward linkages and consortia

Reality FairShare Programme

- Provides public procurement opportunities to MSEs up to US\$160,000
- Provides entrepreneurship and technical skills training
- Establishes a network of MSEs in various sectors

MSE Web-Based Portal

- Establishes roadmap for MSE startup and growth
- Creates a database for MSE access to key support services
 - Online mall
 - Access to Angel Investment and Crowd Funding
 - Access to Business Development Support
- Creates network to facilitate productive linkages

MSME Diaspora Network

- Markets goods and services to culturally similar customers
- Creates opportunities to link with individuals along the value chain (locally and abroad) to supply customers

MONITORING AND EVALUATION

- Establish M&E system to measure results timely and reliably
- Provide feedback to policies and programmes in order to facilitate timely change
- Use the Results Based Management approach to monitor and evaluate at the output, outcome and impact levels
