
What is the SMEPI?

SME Policy Index Objectives

- To compare SME policy across countries and time and measure progress on policy convergence at regional level;
- To assess the level of policy development across key dimensions;
- To identify strong and weak points in policy design and implementation at country level;
- To provide a tool to policy makers and stakeholders to monitor progress in policy implementation.





*M&E – Monitoring and Evaluation







Achievements: 10 years overview of SME Policy in the EU enlargement region



- Effective policy transfer of good practices was observed through the SME Policy Index across a number of areas:
 - SME support agencies established
 - Administrative procedures for businesses simplified
 - Technical standards in line with Single Market requirements
 - Support to innovative SMEs and start-ups provided.



Advantages of the Methodology

- It captures the quality of planning, implementation and monitoring of SME policies, and thus goes beyond the pure existence of strategies and programmes.
- It incorporates qualitative and quantitative questions to provide a more precise assessment for each indicator.
- It integrates national statistics, company-level and independent company-surveys to measure the **performance** of policies on the ground.
- It supports governments in assessing themselves whether they have reached their targets on SME policies and puts an increased focus on monitoring and evaluation.




Coverage of the SMEPI

- Since 2006, the SME Policy Index has been applied 9 times in 4 regions, covering 32 economies in total:
 - EU pre-accession region (the Western Balkans and Turkey) in 2007, 2009, 2012 and 2016
 - Eastern Partnership countries in 2012 and 2016
 - Euro-Mediterranean Partnership Countries in 2008 and 2014
 - ASEAN member countries in 2014.
 - Regional SME policy assessments foreseen in Latin America and the Gulf region

Examples of how participating economies have benefited from the SME PI

- Western Balkans and Turkey: SME PI results are regularly incorporated into the EC Enlargement Strategy Papers and they have been used by participating economies and the EC to design technical assistance programmes. The SME PI results have been taken into account for the establishment of the Western Balkans Enterprise Development & Innovation Facility (EDIF). The findings of the assessments are also instrumental for preparation of annual Economic Reform Programmes in Western Balkans and Turkey.
- Eastern Partner Countries: All six countries have already developed or are currently finalising an SME development strategy based on the assessment results and recommendations contained in the SME PI.
- Mediterranean, Middle East and North Africa: SME PI has been used by individual economies (e.g. Morocco and Egypt) to regularly monitor the SME policy development. The results of the SME PI have been incorporated into the 2015 -2020 SME Development Strategy of Jordan.
- ASEAN: In the Philippines the SME Development Strategy was largely based on the findings from the 2014 ASEAN SME PI. Based on the result of the 2014 SME PI, ASEAN has established a regional task-force to improve company registration procedures.

Project Outputs

- **Final Publication**, with overall assessment per sub-group and specific country notes for each dimension
- Comparable **Benchmarking** and Identification of Strengths and Weaknesses
- **Policy Dialogue** Creation of SME Network
- Basis for future country-specific and regional projects to address revealed priority policy areas (implementation and technicalassistance)
