


## **PLIPDECO OPERATIONAL OVERVIEW**

- Port Operations and Logistics
- 8 shipping lines
- 170k teus of containerised cargo handled annually
  - 15% transhipment
  - 80% FCL
  - 5% LCL (PLIPDECO and other warehouses)
- 300k tonnes of general cargo annually




