



Short History

- In 2005 from the EU under the 9th European Development Fund (EDF) resources were allocated for the "Public Private Partnership Support to the Domestic Private Sector Suriname Business Forum (SBF)" project (Reference no.: 09 ACP SUR 07, Agreement no. 9333/SUR)
- In 2006 the SBF was instituted by law
- Project implementation, after tenders in 2007, started in January 2008

- Development of the Local Private Sector (LPS) through
 - dialogue (PPD)
 - Public Private Partnership (PPP)
 - Strategies that jointly formulate, execute and monitor.

Projects in relation to the Formalize MSME

- Continuation of the Export Readiness project (New sectors + New target countries for export - in negotiation with the CDB)
- Feasibility study for the set up of storage facilities for export of agricultural products/flowers/meat and fish products and live animals
- Follow-up on the greenhouses stimulation project

Projects in relation to the Formalize MSME

- Set up of Knowledge Centre (KC) under the SBC: for Cocoa, Cassava and Podosirie (Acai)
- Creation of a National export mark or extension of the 'Made in Suriname' trademark to a export warranty mark issued by the Ministry of Trade, Industry & Tourism in cooperation with the business community.

Measures that strenghten institutional capacities to promote Formalization

- SBF and BSO (stakeholder organization)
- Promote formalization by increasing the awareness of the business environment to the target group.
- During activities of the organization, participant or members received information of different services, such as tax, Chamber of Commerce, Suriname Bureau of Standards, Basic Medical Care, Pension fund and Credit Guarantee Fund.

Measures that strengthen institutional capacities to promote Formalization

COMMERCIAL REGISTRATION; The Trade Register. Every company in our country is obliged by law to register for / on the Trade Register. Exceptions to this are Government Companies that or not public limited, companies in the agricultural sector that are not limited, associations or foundations and companies that belong to minors who do not have manual guidance

Measures that strengthen institutional capacities to promote Formalization

- This information is necessary for every entrepreneur to make the choice to switch to the formal economy.
- With the One Stop Window one can, for example, go for the drafting of license applications, which saves a lot of running time for entrepreneurs.
 - -Requesting new permits or extensions is simplified.
- Build networks between all the stakeholders and promote and enhance the exchange of knowledge

Obstacles

- No MSME institution
- No specific policy yet in place for MSME's
- No formalization policy for MSME's
- De-politization of government agencies to help MSME's and formulate clear policy on MSME's
- The business service organizations together with the Government are busy to formulate a national definition based on a combination of different indicators: employment, annual turnover, organization structure and type of the sector / industry

Recommendations

- Access to finance with lower interest rates
- Tax facilities: tax holidays, decreasing taxes (income tax, government take, etc.)
- Assistance in market intelligence with optimal product and market combination to explore export markets for primary agricultural products and processed products

Recommendations based on best practices

- Because of the unique structure of our Forum, the SBF makes more use of it by co-funding programs/ schemes/ projects & activities
- Incorporate the National Strategy of the SBF into policy; update the NSAP 2017-2020
- Strengthen the SBC and other BSO's to use them in the implementation of these
